# From the Interim Pastor's Study

As the New Year begins and snow covers the ground, I often turn to the hymn All Beautiful the March of Days by Frances Whitemarsh Wile. Usually sung to the tune of Forest Green by Ralph Vaughn Williams, it has a bright lilting quality to it.



All beautiful the march of days / As seasons come and go / The hand that shaped the rose has wrought / The crystal of the snow...

As I planned worship last week (when I thought we would be gathering in-person even if adapted due to the renewed viral spread, I was chagrined to find that it was not included in our new Presbyterian hymnal Glory to God. But I found myself humming it anyway. For me, this hymn is about the unique beauty of winter as well as a reflection on the movement of time as we wind up the Christmas season and move into the New Year: The seasons come and go..."

We are in the winter season these days, literally and figuratively: COVID continues to dominate our lives with new variations always needing to adapt to the situation of the moment. It isn't what it was in March 2020, but we are still nowhere near what we took for granted in January of 2020. The congregation is now a half year into an "interim period". Now is a time when movement toward finding a new pastor often feels like it has paused in the same way our lives are paused by a large snowstorm - or by ice creating a glassy and dangerous surface on the sidewalk. That pause is frustrating when we are eager to get out and about. And, yet those snow and ice days are often gifts - a fallow time to ponder who we are and what we are about in ways less methodical than formal planning and study. They are important days because they give us time to stop and listen for God's voice and look for God's hand at work in the crystal of the snow.

God works in ways unseen when we think "nothing is happening". But God is really quite busy, calling us to slow down, pray, and move into the New Year with an appreciation for the beauty around us and the gift of time. As the snow and cloud cluttering our minds and hearts begin to clear, we can move on with the tasks before us with a new hope and appreciation for God's wisdom. A direction for pastoral leadership will emerge. A pro-

cess for finding that "right person" will be established in God's good time, and in time a new relationship of pastor and people will begin.

We may not know exactly when that will become clear but can trust that God is at work. As Wile wrote in the final stanza of her hymn: O God, from whose unfathomed Law/ the year in beauty flows.... And so, our year will flow.

#### Utilizing our Church Property

One of the three focuses of the FPC Future Focus study was better utilization of our church property to reflect our values. A subcommittee of the Session has been charged with exploring opportunities to maximize our

property. That committee, comprised of Mike Fahey, John Mehl, and Kathy Danielson, has begun working with the Oikos Project to assess congregational skills and interests, needs of our community, and opportunities to provide revenue for First Presbyterian Church.

A crucial part of this exploration process is involving the full congregation in an exploration of our collective skills and values. The Oikos Project has provided a structured online exercise that will identify shared congregational skills and help us better focus on areas where we might be able to develop a profitable enterprise that is consistent with our values.

The Skills Deck is an easy online exercise that will take less than 15 minutes to complete. We will compile the results of this exercise and hold a congregational meeting to discuss the outcomes and explore next steps.



steps in the search process, it became apparent that it would require a full-time (or almost full-time) pastor to guide the implementation of our Future Focus Initiatives. Session members felt strongly that this initiative - developed a few years ago and approved by the Congregation - is still relevant, meaningful, and what we all want to see in our church.

On the other hand, as we looked at information on such issues as church membership numbers, church participation in general, the long-term uncertainty regarding the pandemic, recruitment of church officers, and finances, a narrower approach seemed practical. Session has had several meetings (and many hours of discussion) trying to discern how FPC would function with a part-time pastor versus a full-time pastor. Those discussions will continue until we reach consensus, hopefully in the next month.



#### Fall/Winter Bible Study

As in previous years, during 2021-22 we will continue the FPC tradition of biweekly Bible study. We will continue tomeet virtually via Zoom every other Tuesday, from

January 4 — April 26 from 7:00 - 8:15 PM

Our focus this year will be reading and discussion of the book The Last Week: What the Gospels Really Teach About Jesus's Final

**Days in Jerusalem**, by Borg & Crossan (amazon link, available as paperback, Kindle e-book, Audible audiobook, or on audio CDs).

The book takes a unique approach, and in eight concise chapters guides us through each day of the Easter Week, day by day (starting with the Palm Sunday, and ending with Easter), following the timeline of the Gospel according to Mark.

Because the book starts with the Palm Sunday (which corresponds to chapter 11 in Mark), during the first five bi-weekly meetings (October - December) we will read and review the first 10 chapters in the Gospel of Mark, reading the text alongside selections from several popular commentaries. You will only need your Bible (New Testament) for these first five meetings - other materials will be provided as electronic (PDF) handouts on the website.

Then, after Christmas/New Year (a 2-week break), starting on Tue. Jan 4, 2022, we will begin reading the Borg-Crossan book, and plan to finish it on Tue. of the Easter Week, April 12, 2022, just in time for Easter which is on April 17, 2022. We will conclude the series on April 26, with a Summary/Reflection meeting.

#### Session Update

Session voted to call a Special Congregational Meeting for January 9, 2021 to hear a report from the Nominating Committee related to the selection of Ruling Elders and Deacons to begin (or continue) their service in 2022.

Voted to hold the Annual Congregational Meeting on January 30, 2022 following worship.

Approved a series of motions to clear the Per Capita Fund deficit by:

- 1. The Per Capita Fund balance be cleared to zero by December 31, 2021, using any Operating Cash surplus, supplemented with FPC Reserve Funds as needed. The Per Capita Fund, as of November 30, is \$6411.20 in arrears.
- 2. The process for managing our per capita donations and payments be simplified to use only the two P&L lines above, with the understanding Per Capita deficits will be reflected in the Operating Cash budget status in future years.
- 3. The Per Capita Fund will be discontinued in 2022.

Approved a revised Position Description for the Treasurer.

Approved a motion from the Mission Committee to approve a \$1500 Shared Mission pledge for 2022.

Approved a motion to allow Alcoholics Anonymous to resume holding meetings in the church assuming they follow Dane County Covid Guidelines, have a Hold Harmless agreement and provide proof of liability insurance.
